

**MINUTES OF THE MEETING OF SELECTION COMMITTEE FOR ENGAGEMENT OF CONSULTANTS TO STAFF THE PROGRAMME MANAGEMENT UNIT(PMU) FOR SKILL DEVELOPMENT OF PERSONS WITH DISABILITIES(PwDs)**

The meeting of Selection Committee for engagement of consultants to staff the Programme Management Unit for Skill Development of Persons with Disabilities was held on **31<sup>st</sup> July, 2015** in the Chamber of Joint Secretary(MJ), 5<sup>th</sup> Floor, Paryavaran Bhavan, C.G.O. Complex, New Delhi.

The following members of the Committee were present in the meeting :-

2. For engagement of consultants on contract basis for the five posts of i) Training Need Assessment, ii) Content Generation, iii) Training Monitoring Certification, iv) Employer Connect and v) IT Support Unit to staff the Programme Management Unit for Skill Development of Persons with Disabilities, shortlisted applicants were called for a Personal Interaction on 31<sup>th</sup> July, 2015.

3. The Selection Committee decided to assess the suitability of the applicants by giving them marks out of 20, and bench mark of 60% was agreed to as minimum qualifying marks i.e. a minimum of 12 marks out of the total of 20 marks. The Committee also decided to keep one candidate in waiting list (scoring second highest marks) in each of the category apart from the selected candidate.

4. The details of the candidates selected by the Selection Committee are as under:
